2018 MEMBERS' EXHIBIT

AT THE DELAPLAINE VISUAL ARTS EDUCATION CENTER JANUARY 6 -JANUARY 27, 2018

The Frederick County Art Association invites its members to participate in an exhibit and sales opportunity. Each member may exhibit one piece of artwork in the exhibit. The artwork may be two dimensional or free standing (e.g. ceramics or sculpture). Please see conditions of exhibitions for details. If a member has volunteered in some way for FCAA in 2017 that member may exhibit two pieces of art. Volunteering includes: serving on the board, providing refreshments at a meeting, hosting the picnic, and actively serving on a committee.

#### **DROP OFF WORK**

Monday, December 18, Noon- 4:30 pm or Saturday, December 30, 1 -4 pm.

#### **PICK UP WORK**

Sunday, January 28, 3-5pm Monday, January 29, 9am-430pm.

#### **ENTRY ELIGIBILITY**

•All FCAA members in good standing with dues paid are eligible to submit their work. New members that joined after June 30, 2017 are paid through the end of 2017.

Submissions are not juried for entry. We will attempt to hang or display all entries.

Entries will be judged for 1, 2 and 3<sup>rd</sup> place awards by an independent juror.

- Work for exhibition must have been completed in last 2 years by a current member of the FCAA and not previously exhibited at the DVAEC.
- Work should be no larger than 36 inches in any dimension, for framed, wall hung work. Work over 36 Inches will be hung if space is available. Ceramics and sculpture should have no dimension greater than 18". Jewelry will be accepted but it should be ready to hang, or display in its own case provided by the artist.
- Artist is solely responsible for shipping/delivery/pickup and any unusual installation requirements.
- Artwork must remain on view for the duration of the exhibit.
- Reproductions (gicleés) of original work in another medium will not be accepted.
- Work must be ready to hang with screw eyes or D-rings and hanging wire appropriate to the weight of the work. **Please-- no saw tooth hangers or frames with table stand attached to the back. This may prevent work from being displayed.**
- DVAEC will retain a 30% commission for works sold during the show. If artist is an individual member of DVAEC, the commission is 20%.

### **Conditions of Exhibition**

Please bring one work per member or two works per member if member meets volunteer status. Second work will be hung subject to space limitations. Work over 36 inches in one direction may require special consideration.

Work for exhibition must have been completed in last 2 years and not previously exhibited at the DVAEC. You must be a current member of the FCAA to participate in this exhibit. Artwork must remain on view for the duration of the exhibit.

Prints must be original and hand pulled. We do not accept giclées or any other reproduction of an existing artwork in another media.

All framed works must be received ready to hang, with wire and D-rings or screw eyes. Please do not use frames with sawtooth mounts or easel backs. Artist is solely responsible for shipping/delivery/pickup and any unusual installation requirements.

DVAEC will retain a 30% commission for any works sold during the show by members. If artist is a DVAEC individual member the commission is 20%.

The DVAEC will insure the artwork from the time of delivery until the designated pick up time, for an amount that shall not exceed the sale price less the commission. All works will be insured by The Delaplaine Visual Arts Education Center upon delivery for loss directly caused by theft, attempted theft, fire, lightning, explosion, windstorm, vandalism, aircraft, rioters, or strikers.

The Center is not responsible for loss caused by or resulting from any of the following: wear and tear, gradual deterioration, hidden or latent defects, or any quality in the property that causes it to damage or destroy itself. Every reasonable care will be taken in the handling of works received. It is recommended that the artist carry his/her own insurance for his/her work in addition to the Center's coverage.
